- 2- INDEMNITY: The applicant(all dojang related parties) and the Releasors agree to indemnify and hold harmless the Releasses from and against any liability, loss, damages, expenses, costs, claims, demands, actions or causes of action arsing out of or in consequence of the applicant's participation in or attendance at the Federation activities, including traveling to and from such Activities or resulting from any decision of an Releasses.
